1.5 Section 1. Minnesota Statutes 2016, section 120A.41, is amended to read:

1.6 **120A.41 LENGTH OF SCHOOL YEAR; HOURS OF INSTRUCTION.**

1.7 (a) A school board's annual school calendar must include at least 425 hours of instruction
1.8 for a kindergarten student without a disability, 935 hours of instruction for a student in
1.9 grades 1 through 6, and 1,020 hours of instruction for a student in grades 7 through 12, not
1.10 including summer school. The school calendar for all-day kindergarten must include at least
1.11 850 hours of instruction for the school year. ~~The school calendar for a prekindergarten~~
1.12 ~~student under section 124D.151, if offered by the district, must include at least 350 hours~~
1.13 ~~of instruction for the school year.~~ A school board's annual calendar must include at least
1.14 165 days of instruction for a student in grades 1 through 11 unless a four-day week schedule
1.15 has been approved by the commissioner under section 124D.126.

1.16 (b) A school board's annual school calendar may include plans for up to five days of
1.17 instruction provided through online instruction due to inclement weather. The inclement
1.18 weather plans must be developed according to section 120A.414.

1.20 Subdivision 1. Days. "E-learning day" means a school day where a school offers full
1.21 access to online instruction provided by students' individual teachers due to inclement
1.22 weather. A school district or charter school that chooses to have e-learning days may have

2.1 up to five e-learning days in one school year. An e-learning day is counted as a day of
2.2 instruction and included in the hours of instruction under section 120A.41.

2.3 Subd. 2. **Plan.** A school board may adopt an e-learning day plan after consulting with
2.4 the exclusive representative of the teachers. A charter school may adopt an e-learning day
2.5 plan after consulting with its teachers. The plan must include accommodations for students
2.6 without Internet access at home and for digital device access for families without the
2.7 technology or an insufficient amount of technology for the number of children in the
2.8 household. A school's e-learning day plan must provide accessible options for students with
2.9 disabilities under chapter 125A.

2.10 Subd. 3. **Annual notice.** A school district or charter school must notify parents and
2.11 students of the e-learning day plan at the beginning of the school year.

2.12 Subd. 4. **Daily notice.** On an e-learning day declared by the school, a school district or
2.13 charter school must notify parents and students at least two hours prior to the normal school
2.14 start time that students need to follow the e-learning day plan for that day.

2.15 Subd. 5. **Teacher access.** Each student's teacher must be accessible both online and by
2.16 telephone during normal school hours on an e-learning day to assist students and parents.

3.5 a written authorization from the pupil's parent permitting the pupil to self-administer the

3.7 school personnel to administer the medication to the pupil. The parent must submit written
3.8 authorization for the pupil to self-administer the medication each school year; or

5.11 resident secondary pupils residing two miles or more from the public or nonpublic school

5.13 but with respect to transportation of pupils to and from nonpublic schools, only to the extent
5.14 permitted by sections 123B.84 to 123B.87;

5.15 (ii) transportation of resident pupils to and from language immersion programs;

5.16 (iii) transportation of a pupil who is a custodial parent and that pupil's child between the
5.17 pupil's home and the child care provider and between the provider and the school, if the
5.18 home and provider are within the attendance area of the school;

5.19 (iv) transportation to and from or board and lodging in another district, of resident pupils
5.20 of a district without a secondary school; and

5.21 (v) transportation to and from school during the regular school year required under
5.22 subdivision 3 for nonresident elementary pupils when the distance from the attendance area
5.23 border to the public school is one mile or more, and for nonresident secondary pupils when

7.13 30, a homeless student ~~from a temporary nonshelter home~~ in another district to the school
7.14 of origin, or a formerly homeless student from a permanent home in another district to the

10.18 subdivision 1, may be increased in the amount approved by the voters of the district at a
10.19 referendum called for the purpose. The referendum may be called by the board. The
10.20 referendum must be conducted one or two calendar years before the increased levy authority,
10.21 if approved, first becomes payable. Only one election to approve an increase may be held
10.22 in a calendar year. Unless the referendum is conducted by mail under subdivision 11,
10.23 paragraph (a), the referendum must be held on the first Tuesday after the first Monday in
10.24 November. The ballot must state the maximum amount of the increased revenue per adjusted

11.13 adjusted pupil units for the school year beginning in the year after the levy is certified shall
11.14 be authorized for certification for the number of years approved, if applicable, or until
11.15 revoked or reduced by the voters of the district at a subsequent referendum.

11.16 (b) The board must ~~prepare and~~ deliver by ~~first class~~ mail at least 15 days but no more
11.17 than 30 days before the day of the referendum to each taxpayer a notice of the referendum
11.18 and the proposed revenue increase. The board need not mail more than one notice to any
11.19 taxpayer. For the purpose of giving mailed notice under this subdivision, owners must be
11.20 those shown to be owners on the records of the county auditor or, in any county where tax
11.21 statements are mailed by the county treasurer, on the records of the county treasurer. Every
11.22 property owner whose name does not appear on the records of the county auditor or the
